

# **General Conditions of Use**

Welcome to the Quantum Network Explorer Platform, a state-of-the-art experimental quantum networking platform developed by <u>QuTech</u>, a collaboration founded by <u>Technische Universiteit Delft</u> and <u>TNO</u>, ("**QNE**," "**we**," or "**us**"). Hereby we explain under which terms You may use our online website https://www.quantum-network.com/ ("**Website**") and software provided on or in connection with the Quantum Network Explorer (collectively the "**Service(s**)"). By accessing or using the Service, You acknowledge that You have read, understood, and agree to be bound by these Conditions of Use ("**Conditions**") and to the collection and use of your personal data as set forth in the QNE Privacy Policy. These Conditions apply to all Website visitors, users, and others who access the Service ("**User(s**)" or "**You**").

Please read these Conditions carefully and in full before using, registering or otherwise using the Website.

## 1. Use of the Service

QNE is a quantum networking platform designed and built by QuTech. It provides Users a variety of ways to run quantum network applications and examine the results. It provides a graphical interface to select and configure simulated quantum networks and applications and to visualize the quantum network, simulation steps, and results.

QNE is initiated by <u>QuTech</u> an advanced research center for quantum computing and quantum internet, resulting from a collaboration founded by <u>Technische Universiteit Delft</u> ("**TUD**") and <u>TNO</u>. We want to provide Users access to various high-tech technologies to perform quantum computations and insights in principles of quantum networking and access to the community.

A. Eligibility

As QuTech is no legal entity, we must make clear towards You that the service is offered by TUD, also on behalf of its QuTech partner TNO. The Conditions will legally bind You towards TUD. By any form of use of the Service, whether it be by accessing, uploading or running code or downloading any results of processing, You agree to be bound by these Conditions of use. If You do not agree, You may not use the Service. Supplemental prevailing terms and conditions may apply to some Services, such as rules for a particular promotion, service or other activity, if applicable they will be disclosed to You.

B. Use of the Service

By using our Service You agree to apply adequate security policies and tools on your own networks and systems used to gain access to QNE, e.g. state-of-the-art scanners for viruses, to prevent unauthorised use of or access to QNE by third parties. You also agree to take precautions to avoid unnecessary loss of processor hours, e.g. by using the application configuration tools provided by QNE and to reasonably report any detected or perceived errors in our Service(s) (in for example the software, compilers, data communication) and system disruptions to QuTech (contact details below).



Subject to these Conditions, You are hereby granted a non-exclusive, limited, non-transferable, freely revocable license to use the Service for your personal, non-commercial use only and as permitted by the features of the Service. We reserve all rights not expressly granted herein in the Service and the QNE Content (as defined below). We reserve the right to terminate this license at any time for any reason.

The Services/computing resources (quantum networks and quantum network simulators) are shared by all Users. Requests for running an experiment may not be executed immediately but will be placed on a queue. Each backend imposes a limit on the computational resources used in our backend servers. In addition, a limit on the amount of time an experiment may run will be enforced by aborting running experiments that exceed this limit. Experiments has to be parameterized on the website or submitted via the API (either by using an ADK or SDK by initiating requests to the API directly). Limits apply to the number of experiments that can be stored in the result database.

To accept that the Service is offered by us on a reasonable efforts basis and that interruptions of the service may take place at any time, announced or not-announced. The Service may make use of external HPC-capacity which is limited by its very nature. Therefore, our staff, or staff of third party providers of computing and storage facilities utilized by us, shall have the following rights: (I) To assign priority to particular jobs without regard to the order of the queue; (II) To assign computing or storage resources to the uploaded jobs; (III) To relay certain jobs to external providers of computing or storage capacity without prior notification to You. Please note that it cannot be prevented that such providers gain access to experiments or code uploaded by You, unless explicitly agreed otherwise; (IV) To may decide not to execute or store a particular programmed application or to suspend or to delete an associated job or process in case it would exceed the available computer time of our server and/or third party computing or storage capacity utilized by us or systems of external providers that are used for QNE.

To manage the system usage and limit as much as possible the system downtime due to maintenance or any other unforeseen reasons. Normal downtime will be scheduled well in advance and will be announced on the Website.

#### C. QNE accounts

Your QNE account gives You access to the Services and functionalities that we may establish and maintain from time to time and in our sole discretion. By connecting to QNE with a third-party service, You give us permission to access and use your information from that service as permitted by that service, and to store your log-in credentials for that service.

When You create an account, You are obliged to provide accurate and complete information. You are solely responsible for the activity that occurs on your account, and You must keep your account password secure. Your account and associated login/password combinations are strictly personal and may not be shared with other persons within your organisation or with other organisations/persons. You must notify us immediately of any breach of security or unauthorized use of your account. We are not liable for any losses caused by any use or unauthorized use of your account. Therefore You assume responsibility for protecting that data and assume liability for any damage resulting from the misuse by any party of own usernames, account numbers and passwords.

#### D. Prohibited use

It is prohibited to use QNE and/or the Service for other purposes than to explore, learn and share quantum networking applications. The following activities are in any case prohibited:



- copying, distributing, or disclosing any part of the Service in any medium, including without limitation by any automated or non-automated "scraping";
- transmitting spam, chain letters, or other unsolicited email;
- attempting to interfere with, compromise the system integrity or security or decipher any transmissions to or from the servers running the Service;
- taking any action that imposes, or may impose at our sole discretion an unreasonable or disproportionately large load on our infrastructure;
- uploading invalid data, viruses, worms, or other software agents through the Service;
- collecting or harvesting any personal data from the Service;
- impersonating another person or otherwise misrepresenting your affiliation with a person or entity, conducting fraud, hiding or attempting to hide your identity;
- interfering with the proper working of the Service;
- accessing any content on the Service through any technology or means other than those provided or authorized by the Service; or
- bypassing the measures we may use to prevent or restrict access to the Service, including without limitation features that prevent or restrict use or copying of any content or enforce limitations on use of the Service or the content therein.

We may, without prior notice, change the Service or stop providing the Service to You or to Users generally; or create usage limits for the Service. We may permanently or temporarily terminate or suspend your access to the Service without notice and liability for any reason, including if in our sole determination if You violate any provision of these Conditions, or for no reason. Upon termination for any reason or no reason, You continue to be bound by these Conditions.

## 2. User content

The Service allows Users to post content such as quantum networking applications or other content or information ("**User Content**"). We claim no ownership rights over User Content created by You nor the output data. The User Content You create remains yours; however, by sharing User Content through the Service, You agree to allow others to view, edit, and/or share your User Content, even when You have deleted your account, in accordance with your settings and these Conditions. We reserve the right in our sole discretion to remove any User Content that is shared via the Service.

You agree not to post User Content that:

You have the written consent of each rightful claimant for using your User Content for our Services, if any, and each such rightful claimant has released You from any liability that may arise in relation to such use. We are not responsible and are not liable for any User Content that You or any other User or third party posts or sends over the Service. The Service is limited up to a maximum number of 50 experiments per User stored in the application database at any moment. We reserve the right to determine eligibility for use of the free version ("**Free Version**").

### B. Paid version

Additional benefits and features of the Service may be provided for a fee or other charge in the (near) future. Compared to the Free Version of our Services, the paid version offers additional benefits and features to these Conditions ("Paid Version").

For clarity; the Conditions in this document from which the paid version does not differ remain in full force and effect, expressly including the "AS IS" provision below. In addition, we make every reasonable effort to offer confidentiality in accordance with the ISO27001 standard, article 9 is again explicitly applicable here. If You want to use the Paid Version of the Service, You agree to the pricing and payment terms, as we may update them from time to time. We may add new benefits and/or features for additional fees and charges, or amend fees and charges for existing benefits and features, at any time in its sole discretion. Any change to our pricing or payment terms shall become effective in the billing cycle following notice of such change to You as provided in the Conditions or otherwise.

You may cancel your QNE account and/or subscription at any time; however, there are no partial or pro-rata refunds for cancellation. If You cancel your account and/or subscription, cancellation will be effective at the end of the current monthly or annual billing period; You will have continued access to your subscription for the remainder of that period, but You will not receive a refund. QNE may offer partial, pro rata refunds for QNE's early suspension, termination, or cancellation of a paid Service,



where the pricing and payment terms for the specific QNE paid Service expressly state that such refunds are available in such scenarios and/or as required by law. In the event that You cancel your account or QNE suspends or terminates your account under these Conditions for your breach of these Conditions, You understand and agree that You shall receive no refund or exchange for any unused time on a subscription, any license or subscription fees for any portion of the Service, any content or data associated with your account, or for anything else.
